Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 22/09/2017 considered the Council Assessor's Report (03.07.2017) on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 02 seats at Hassan Institute of Medical Sciences, Hassan granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (03.07.2017) and decided to recommend to the Central Government that MD(Physiology) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Hassan Institute of Medical Sciences, Hassan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

The minutes of the Postgraduate Medical Education Committee were forwarded to the Oversight Committee vide Council letter dated 26.09.2017 for approval.

In reference to above, the Oversight Committee vide their letter dated 29.09.2017 had conveyed as under: -

2. It was noted that the assessor has noted certain negative remarks deficiencies in case of item numbers 10, 18 and 67, yet MCI has decided to recommend grant of recognition without recording reasons for overruling assessor. Therefore, the Oversight Committee desires that MCI may have relook at these cases and record the reasons to overrule the assessor's remark.

Accordingly, the Council Assessor's Report (03/07/2017) on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 02 seats at Hassan Institute of Medical Sciences, Hassan granted by Rajiv Gandhi University of Health Sciences, Bangalore along with the recommendations dated 29/09/2017 of the Oversight Committee was reconsidered by the Postgraduate Medical Education Committee at its meeting held on 27/10/2017 and the Committee decided as under:

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (03/07/2017) on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 02 seats at Hassan Institute of Medical Sciences, Hassan granted by Rajiv Gandhi University of Health Sciences, Bangalore along with the recommendations dated 29/09/2017 of the Oversight Committee and observed that:
