I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 27/07/2017 considered the Council Assessor's Report (May, 2014) and compliance dated 24/04/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD/MS(Anatomy) qualification for 02 seats at Hassan Institute of Medical Sciences, Hassan granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2014) and compliance dated 24/04/2017 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(Anatomy) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Hassan Institute of Medical Sciences, Hassan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
