Subject: Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD/MS(Ophthalmology) qualification for 02 seats in respect of students being trained at Hassan Institute of Medical Sciences, Hassan.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 24.04.2018 considered the Compliance verification Report (09.02.2018) and Council Assessor's Report(s) (June, 2017) on the standard of examination and other teaching facilities available for Recognition of MD/MS(Ophthalmology) qualification for 02 seats at Institute of Hassan Institute of Medical Sciences, Hassan granted by Rajiv Gandhi University of Health Sciences, Bangalore. The Committee decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment (09/02/2018) along with the Council Assessor's Report (June, 2017) and compliance dated 12/10/2017 submitted by the college authorities and decided to recommend to the Central Government that MD/MS(Ophthalmology) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Hassan Institute of Medical Sciences, Hassan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 04.05.2018.
