Sir/Madam,

In continuation of this Ministry's letter of even number dated 12.05.2017 and your letter No.HIMS/UNI/MCI/45/CR(UG)/2016-17 dated 16.05.2017 furnishing required undertaking, I am directed to convey the formal permission of the Central Government to your College for increase of intake capacity from 100 to 150 in MBBS course for the academic year 2017-18 under Section 10 A of the IMC Act, 1956.

2. This permission of the Central Government is accorded initially for a period of one year and will be renewed on yearly basis subject to verification of achievement of annual targets as indicated in your scheme. This process of renewal of permission will continue till such time the infrastructure and expansion of hospital facilities are completed as per norms of Medical Council of India. The next batch of students against increased intake shall be admitted only after obtaining permission of the Central Government.
3. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.
4. Discrepancies, if any, may be brought to the notice of MCI and Central/State Government.
