Notification

As per Medical Council of India guidelines pertaining to Graduate Medical Education Regulations vide clause 6(1) and (2) Migration of students from one college to another is permissible only if both the colleges are recognized by Central Government under section 11(2) the IMC Act 1956.

Further as per Clause 6(1) (4), the office of Director of Medical Education will take a final decision in the matter as to whether or not to allow migration in accordance as per the provisions of MCI/NMC regulations and communicate the same to the applicant student within a period of one month from the date of receipt of their request for migration.

The procedure laid down for effecting Migration Transfer for the year 2021-22 is as the follows.

- 1. Recognized Medical Colleges should publish the number of seats available for Migration Transfer in their respective website under intimation to DME's office. The number of seats available for Migration Transfer is subject to the condition, that, it shall not exceed 5% of the sanctioned annual intake capacity of the college, which shall be arrived at after the announcement of supplementary exam of 1St year MBBS course results from Rajiv Gandhi University of Health Sciences.
- 2. Recognized Medical colleges, wherein, the students have opted out of the Institution and all the recognized Medical Colleges wherein the students have opted in to come into the Institution shall invite applications for Migration Transfer from interested candidates. This procedure shall be completed before the completion of 7th September 2021.
- It shall be brought to the notice of the students requesting for migration by the Principals of the Medical Colleges that migration transfer is subject to the candidate fulfilling any of the below mentioned conditions.
 - a) Death of one of the parent in the preceding year (Death Certificate should be enclosed).

- b) One of the parents is terminally ill/incapacitated/bed ridden/irreversible organ damage/having orthopedic handicap of 65% and above or permanent visual impairment of 50% and above.
- c) If the candidate has physical disability which necessitates the care by parents.
- d) In case the candidate is seeking transfer to his/her home town, such candidate will not be given hostel facilities.
- e) If the candidate is suffering from ailment for which treatment is not available in the place where he/she is studying.
- No Migration will be permitted on any ground from one medical College to another located within the same city.
- 5. The Medical Colleges from where the student is opting out and the receiving Medical College where the student is opting to come in shall prepare a merit list of all applicants who have applied for Migration Transfer.
- 6. The colleges shall issue NOC to the candidates as per provision mentioned in para 3 before the 13th August 2021. Subject to the condition that Migration Transfer in both the outgoing and receiving Medical Colleges is restricted to 5% of the annual sanctioned intake capacity of the college or the existing vacancy in respective colleges.
 - The Rajiv Gandhi University of Health Sciences is requested to issue "No Objection Certificate" to eligible candidates before 17th August 2021.
 - 8. The students possessing No Objection Certificates from the outgoing Medical College, receiving Medical College & RGUHS shall apply in prescribed format, along with undertaking and original No Objection Certificates to the Director of Medical Education as on before 24th August 2021.
- 9. Where ever the Migration is sought, the Director of Medical Education shall in turn refer the cases of students to Medical Board to examined the cases on case to case basis on Medical grounds.
- 10. The Medical Board shall give its opinion regarding eligibility for migration transfer by 27th August 2021.
- 11. The Directorate of Medical Education will issue Migration Orders to eligible candidates on before 3rd September 2021.
- 12. Such of the students who have been given Migration Orders shall report to receiving Medical College by 7th September 2021.
- 13. Wide Publicity shall be given to all the students seeking Migration Transfer about the schedule by putting up the circular in all the Institutional

websites and Notice Boards, to ensure transparency and provide equal opportunity to all eligible candidates.



14. All Migration Transfers are to be effected as per the existing Medical Council of India/National Medical Commission rules and regulations. No Migration Transfer is permissible from or to the permitted or unrecognized Medical Colleges.

15. On Migration Transfers are subject to final approval by Medical Council of

India or competent designated regulatory authorities.
