NOTIFICATION

As per MCI guidelines pertaining to Graduate Medical Education Regulations vide clause 6(1) and(2), migration of students from one college to another is permissible only, if both the colleges are recognized by Government of India under section 11(2) the IMC Act 1956.

Further, as per Clause 6(1) (4), the office of Director of Medical Education, will take a final decision in the matter as to whether or not, to allow migration in accordance with the provisions of MCI/NMC regulations and communicate the same to the applicants within a period of one month from the date of receipt of their requests for migration.

The procedure laid down for effecting Migration Transfer for the year 2023-24 is as the follows.

- 1. Recognized Medical Colleges should publish the number of seats available for Migration Transfer, in their respective websites, under intimation to DME's office. The number of seats available for Migration Transfer, is subject to the condition that, it shall not exceed 5% of the sanctioned annual intake capacity of the college, which shall be arrived at, after the announcement of supplementary exam of 1st year MBBS course results from Rajiv Gandhi University of Health Sciences.
- Recognized Medical colleges wherein, the students have opted out of the Institution and all the recognized Medical Colleges wherein the students have opted in to come into the Institutions, shall invite applications for Migration Transfer from interested candidates. This procedure shall be completed before 23rd May 2023 (23-05-2023).
- 3. It shall be brought to the notice of the students requesting for migration by the Principals of the Medical Colleges, that migration transfer is subject to the candidates fulfilling any of the following conditions.
 - Death of one of the parents in the preceding year (Death Certificate should be enclosed).
 - b. One of the parents is terminally ill/incapacitated /bedridden/irreversible organ damage/having orthopaedic handicap of 65% and above or permanent visual impairment of 50% and above. (Medical Certificate Should be enclosed).

- c. If the candidate has physical disability which necessitates the care by parents and in case the candidate is seeking transfer to his/her home town, such candidates after Migration Transfer will not be given hostel facilities and they (physical disability) would be treated as days scholar.
- d. If the candidate is suffering from ailment for which treatment is not available in the place where he/she is studying.
- 4. No Migration will be permitted on any ground from one medical College to another located within the same city.
- 5. The Medical Colleges from where the student is opting out and the receiving Medical College where the student is opting to come in, shall prepare a merit list of all applicants who have applied for Migration Transfer.
- 6. The following table indicates the eligibility of candidates for Migration transfer from one Institute to the other:

7. The colleges shall issue NOC to the candidates as per provision mentioned in para 3 before 23rd May 2023 (23-05-2023), subject to the condition that Migration Transfer in both the outgoing and receiving Medical Colleges, is restricted to 5% of the annual sanctioned intake capacity of the college or the existing vacancy in the respective colleges.

- 8. Rajiv Gandhi University of Health Sciences, Karnataka, are requested to issue "No Objection Certificate" to eligible candidates before 26th May 2023 (26-05-2023).
- The students in possession of No Objection Certificates from the outgoing Medical College, receiving Medical College & RGUHS/Deemed Universities/Private Universities in the State of Karnataka, shall apply in the prescribed format, along with an undertaking with original No Objection Certificates, to the Director of Medical Education on or before 29th May 2023 (29-05-2023).
- 10. Wherever the Migration is sought, the Director of Medical Education shall in turn refer the cases of students to Medical Board to examine the cases on case-to-case basis for their geniuses on medical grounds.
- 11. The Medical Board shall give its opinion regarding eligibility or otherwise for migration transfer by 03rd June 2023 (03-06-2023).
- 12. The Directorate of Medical Education will issue Orders for Migration to eligible candidates on or before 7th June 2023 (07-06-2023).
- 13. Such of the students who have been given Migration Orders shall report to receiving Medical College on or before 9th June 2023 (09-06-2023).
- 14. In respect of cases seeking migration transfer from one institution to the other located in different States and the colleges are affiliated to different Universities, such of these cases shall be referred to the Ministry of Health and Family Welfare services Government of India for further needful.
- 15. Wide Publicity shall be given to all the students seeking Migration Transfer, about the schedule, by putting up the circular in all the Institutional websites and Notice Boards, to ensure transparency and provide equitable opportunity to all eligible candidates.
- 16. All Migration transfers are to be effected as per the National Medical Commission rules and regulations. No Migration Transfer is permissible from or to the permitted or unrecognized Medical Colleges.
- 17. All Migration Transfers are subject to final approval by National Medical Commission or competent authorities designated by the regulators.

The prevailing Regulations on Migration of students from one medical college to another medical college as prescribed against Clause-6 in the Graduate Medical Education Regulation, 1997(Amended)", reads as under:-

Migration Rules and Regulations

- (1) Migration of students from one medical college to another medical college may be granted on any genuine ground subject to the availability of vacancy in the college where migration is sought and fulfilling the other requirements laid down in the Regulations. Migration would be restricted to 5% of the sanctioned intake of the college during the year. No migration will be permitted on any ground from one medical college to another located within the same city"
- (2) Migration of students from one College to another is permissible only if both the colleges are recognised by the Central Government under section 11(2) of the Indian Medical Council Act,1956 and further subject to the condition that it shall not result in increase in the sanctioned intake capacity for the academic year concerned in respect of the receiving medical college.
- (3) The applicant candidate shall be eligible to apply for migration only after qualifying in the first professional MBBS examination. Migration during clinical course of study shall not be allowed on any ground.
- (4) For the purpose of migration an applicant candidate shall first obtain "No Objection Certificate" from the college where he is studying for the present and the university to which that college is affiliated and also from the college to which the migration is sought and the university to it that college is affiliated. He/She shall submit his application for migration within a period of 1 month of passing (Declaration of result of the 1st Professional MBBS examination) alongwith the above cited four "No Objection Certificates" to: (a) the Director of Medical Education of the State, if migration is sought from one college to another within the same State **or** (b) the Medical Council of India, if the migration is sought from one college to another located outside the State.

(5) A student who has joined another college on migration shall be eligible to appear in the IInd professional MBBS examination only after attaining the minimum attendance in that college in the subjects, lectures, seminars etc. required for appearing in the examination prescribed under Regulation 12(1)

<u>Note-1:</u> The State Governments/Universities/Institutions may frame appropriate guidelines for grant of No Objection Certificate or migration, as the case may be, to the students subject to provisions of these regulations.

<u>Note-2:</u> Any request for migration not covered under the provisions of these Regulations shall be referred to the Medical Council of India for consideration on individual merits by the Director (Medical Education) of the State or the Head of Central Government Institution concerned. The decision taken by the Council on such requests shall be final.

Note-3: The College/Institutions shall send intimation to the Medical Council of India about the number of students admitted by them on migration within one month of their joining. It shall be open to the Council to undertake verification of the compliance of the provisions of the regulations governing migration by the Colleges at any point of time."
